

**VIDYASAGAR EVENING COLLEGE**  
**NOTICE/ 03-01-2017**

With reference to the official notification of the University of Calcutta (Notification No-C/636/Students' Union Election dated 26.12.16) it is hereby notified that the Election to the Students' Union of the College, of the year 2016-'17 will be held on 28.1.17.

The following directives are being issued by the Election Commission of the College:

1. Election to be held for 54 Class Representatives (three from each class and year) of B.A., B.Sc and B.Com sections, Honours as well as General.
2. A provisional Electoral Roll for the First, Second and Third Year (B.A., B.Sc and B.Com) students will be published on 4.1.17. Students are directed to verify their names and roll nos. from the said Electoral Roll in the Notice Board at the New Building and report any discrepancy to Sri Amit Nayak, in the College Office.
3. All bonafide students are eligible to cast their votes.  
Bonafide students will be identified as follows:
  - For 1<sup>st</sup> Year (Hon's & General) Students – valid Fee-book and Identity card for the Year 2016-17
  - For 2<sup>nd</sup> Year (Hon's & Gen.) Students – Fee slip along with photo copy/ computer print copy of the mark-sheet of the Part-I examination if it is published before 17<sup>th</sup> January, 2017 and/or the identity card for the year 2016-17
  - For 3<sup>rd</sup> Year (Hon's & Gen) students –Fee slip/Fee Card along with photo copy of Part-II mark sheet and/or the identity card for the year 2016-17.
4. The entry of casual students will be restricted from 16<sup>th</sup> January, 2017
5. Provisional admission will remain suspended on and from 7<sup>th</sup> January, 2017
6. Nomination forms will be issued from college premises on 17<sup>th</sup> January, 2017, Tuesday from 3 p.m to 5 p.m.
7. Students will be allowed to enter the college premises from 2:30 p.m on 17<sup>th</sup> January, 2017.
8. Only the students who intend to collect nomination form will be allowed to enter the college premises on 17<sup>th</sup> January, 2017 against production of valid documents (as mentioned in serial no.3) at the entrance.
9. Students trying to enter the college premises without valid documents as stated in serial no. 3 will have to face disciplinary action.
10. Students entering the college premises for Nomination Forms may be searched and if found in possession of weapons will face strict disciplinary action.
11. Nomination forms can be submitted with fee card/ slip and photo copy/computer print copy of mark sheet (2<sup>nd</sup> Year and 3<sup>rd</sup> year) at the college premises on 18<sup>th</sup> January, 2017 from 5:00 p.m to 6:00 p.m.
12. Each Nomination Form duly proposed and seconded shall have to be submitted in the prescribed form in such manner and time as notified above.
13. A nomination shall be treated valid only if the Nominee, the Proposer, Secunder are bonafied students of the respective class of the college on the date of scrutiny with names in Electoral Roll.
14. Nomination form can be withdrawn by the candidate him/her self from the college premises on 20<sup>th</sup> January, 2017 from 6:00 to 7:00 p.m.
15. The time displayed at the entrance of the premises will be followed for all electoral purpose.
