ne Objectives of the MoU

- 1. The MoU is interdisciplinary in nature, primarily involving common departments and allied subjects of both colleges.
- 2. Faculty Exchange Programme- The above departments of the above institutions shall be exchanging their faculties (online/offline as the case may be) in order to impart lectures that will enhance knowledge of the students.
- 3. Student Exchange Programme- Each of the institutions will be sending over the willing students to the other institution's campus to learn relevant and allied topics from the other discipline through seminar/workshop etc.
- 4. Collaborative Wall Magazine- The selected students of each of the institutions shall collaborate, communicate amongst each other to prepare wall magazines. Each of such wall magazine shall be made in two copies and the respective institution shall be dehig/possessing the wall magazine.
- Joint Research Activities- The above institutions shall co-operate, explore in collaborative interdisciplinary research wherever feasible.
- 6. Joint teaching-learning and internship
- 7. Joint field trip, excursion, and education tour
- 8. Joint training, add-on, certificate and vocational courses.
- 9. Joint extension activities, consultancy.
- 10. Joint faculty and staff development programmes.
- 11. Co-hosting and participation in conferences, seminars, symposiums, and workshops, book fairs etc.
- 12. Collaborative programmes in Capacity building and skills enhancement initiatives like Soft skills, Language and communication skills
- 13. Collaborative programmes in Life skills (Yoga, physical fitness, health and hygiene).
- 14. Collaborative programmes in ICT/computing skills
- 15. Collaborative programmes in competitive examinations, career counselling, sports and cultural events
- 16. Any other activity that is mutually agreed upon and is beneficial to both.

Point of Contact

Both the institutions shall be assigning an individual as a Point of contact for carrying out the above said activities.

Financial Obligation

The agreement is absolutely non-financial in nature and does not involve any monetary transactions between the parties for carrying out the objectives of the MOU.

Tenure and Renewal of the MOU

The understanding should initially be for a period of three years and shall be renewed on the mutual consent of both the institutions.

Termination of the MOU

- The MOU shall be terminated in writing and with the mutual consent of both the institutions and involvement of both the heads of institutions will be must in case offermination.
- In case of any dispute concerning this understanding the same shall be tried in mediation through the respective representatives of this understanding or any other person nominated by them.
- · All disputes and differences arising out of this understanding if not settled in mediation shall be resolved in arbitration before a sole arbitrator to be jointly nominated by both the institutions herein to that effect upon mutual discussion and in terms of provisions of the arbitration and conciliation act 1996(as amended till date). The proceedings before the arbitrator shall be in English.
- The laws of India shall be followed while adjudicating the disputes under this understanding.
- The venue of the arbitration shall be decided by the parties with mutual consent within the limits of the city of Kolkata.

Effective Period of Memorandum

This cooperation agreement shall become effective as soon as the authorized persons of both sides agree on it. There will be two copies of the memorandum equally valid one for each party effective from its dates of signing.
