

 - 6.5. Conduct RICE Merit Scholarship Test, preferably once a year, to offer to the deserving candidates special fees structure on the various Offline Courses
 - 6.6. Conduct free Mock Interview sessions for College students/ Alumni periodically.
 - 6.7. Conduct free Sample Mock Test sessions for College students/ Alumni periodically
 - 6.8. Conduct Special Motivation Classes from the successful students of RICE periodically.
 - 6.9. Share success stories in future with the college placement cell if any
7. Obligations of COLLEGE:-
 - 7.1. Extend co-operation to conduct the above programs on mutually convenient date and time;




