I. Background:

Whereas, the College is committed to addressing environmental issues and promoting sustainability within its campus and surrounding community; and

Whereas, the SAFE has extensive experience and expertise in environmental conservation and is dedicated to supporting educational institutions in their sustainability efforts; and

Whereas, both parties recognize the value of collaboration in developing and delivering educational programs to address environmental issues.

II. Terms of Collaboration:

1. Certificate Course Development:

The College and the NGO agree to collaborate on the development and delivery of certificate course(s) focused on environmental sustainability. This course will cover topics such as Organic Composting,, Aqua culture, Herbal Gardening & Vertical gardening, Mushroom Cultivation, climate change, waste management, Environmental quality monitoring, Energy conservation, Biodiversity etc. The financial transactions during the conduction of such courses are determined on a case-by-case basis through mutual consent.

2. Curriculum Design:

Both parties will work together to design the curriculum, course materials, and learning objectives for the certificate course. The SAFE will provide subject matter expertise and resources to support curriculum development.

3. Advisory Services:

The NGO will provide advisory services to the College to assess current environmental practices and identify areas for improvement. This may include conducting environmental audits, providing recommendations for sustainable practices, and assisting in the implementation of environmental initiatives. The financial transactions during the conduction of such courses are determined on a case-by-case basis through mutual consent.

4. Monitoring and Evaluation:

Both parties will jointly monitor and evaluate the effectiveness of the certificate course and advisory services, making adjustments as necessary to ensure alignment with goals and objectives.

5. Financial Terms:

The financial terms associated with the collaborative efforts outlined in this MOU shall be determined on a case-by-case basis through mutual agreement between the College and the SAFE.

III. Term and Expiration of the Agreement

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of **Three** years. After these three years, it will be mutually extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. Any additions, changes, or deletions to this document must be approved by the representatives of both Parties. All notices shall be in writing and shall be directed to these representatives.

IV. DISPUTES

If any disputes arise in respect to the MoU, in that case, both organizations will discuss and settle the matter amicably.
