



- The schedule of the Internal Examinations are informed to the students beforehand in form of notices in the college website and also informed through corresponding departmental and/or mentor- mentee Whatsapp groups.
- The Faculty members/mentors also inform and discuss the schedule, syllabus and mechanisms of the Internal Examinations during their classes.
- For External Examinations conducted by University of Calcutta, The University Form Fill up schedule, Examination schedule and Admit Card distribution dates are circulated widely through the College Website (as Notifications) and Whatsapp messages.
- The internal examination grievance redressal mechanism ensures complete transparency:
 - The teacher distributes evaluated answer scripts to students, and any clarifications or grievances are addressed by the teacher.
 - Faculty members address doubts or concerns raised by students to help them improve their performance in future assessments.
 - In cases where discrepancies such as errors in question papers, marking allocation, or corrections are identified by students, the respective teacher resolves the issue, and necessary corrections are implemented.
 - If a student remains dissatisfied with the resolution provided by the teacher, they have the option to escalate the matter to the Head of the Department (HoD) concerned or Principal.
 - All such representations are received with a positive outlook and, if deemed necessary, reassessed by another teacher/mentor to ensure fairness and accuracy in the evaluation process.
- The students can lodge their grievances regarding External examination. The students can register their grievances and complaints to Examination Sub-Committee through the Head of the Department or the Faculty members. The teachers remain in constant communication with the students which enable them to understand the grievances and issues even in the absence of formal complaints.



- Post-Publication Review/Re-examination/ Self Inspection of Scripts after the publication of results of University Examinations can be done by the students following University notification and guidelines.
- The Review/Re-examination/ Self Inspection application form submission is done through the online mode in the Calcutta University portal. The College circulates the University Review notifications through the College website and sends Whatsapp messages. After the online submission of such forms, the college approves the list and submits requisite fees to University.

The aforesaid mechanism is followed so that students dissatisfied with their marks and having grievances can seek redressal of the same.

Despite of continuous communication and mentoring the students regarding these issues, some of them fail to submit University Examination application form in due time or do mistakes regarding choice of proper paper/subject during university form fill up. These matters are considered sympathetically and the Examination Sub-Committee through the Principal always tries to resolve the issues with continuous communication with office of the Controller of examinations, University of Calcutta.

Some of the examination related issues regarding form fill up, erroneous entry of marks, wrong result obtained from University etc. are listed below along with supporting documents of redressal of related grievances.

1. Ashish Agarwal (Registration No 224-1111-0908-19) got admission against transfer from another college during the academic year 2019-20 but he was unable to continue his study in our college as the relevant portal of University of Calcutta did not bear his name and details as a student of Vidyasagar Metropolitan College. College authority contacted University through letter number VMC/CU/CoE/12A/21 dated 16/1/2021 and took necessary steps so that University portal be corrected. Subsequently he had appeared B.Com 1st Semester Honours Examination 2020 and cleared University


